ORDER:

For the reasons stated by the Director of Animal Husbandry and Veterinary Services in the letter second read above, the following amendment is issued to the Government Order first read above:-

AMENDMENT

For the existing para 6 and 10 of the Government Order first read above, the following shall be read:-

6. The Government, after careful examination of the proposal of the Commissioner of Animal Husbandry and Veterinary Services, accord administrative sanction and financial sanction for a sum of Rs.2,61,31,000/- for implementation of the scheme of "Introduction of new livestock genetic pool in the Departmental Farms of Tamil Nadu".

10. The Government also direct the Director of Animal Husbandry and Veterinary Services to develop a "Common Consumer Portal for Animal Husbandry and Veterinary Services and Fisheries" Directorates which will enable entrepreneurs and citizens to procure the cattle and other animals, fish etc., sold from Animal Husbandry / Fish Farms which will also help the farms to anticipate demand and produce the particular species which are in demand"

Further para 11 of the Government Order first read above shall be read as follows:

11. The Director of Animal Husbandry and Veterinary Services is directed to remit all the sale proceeds of cattle, goat, pig, etc. wherever sold in farms into the Government account from time to time.

Para No.11 of the Government Order first read above shall be read as para No.12.


